[BY AUTHORITY.]

To incorporate the subscribers to certain Banks in the District of Columbia, and to prevent the circulation of the notes of unincorporated associations within the said District.

A REMARKABLE DREAM.

OF THE LATE DR. DODDRIDGE.

The Doctor and Doctor Clark had been conversing together one evening, upon the nature of the separate state, and the probability that the scenes on which the soul would enter on its' leaving the body; would bear some resemblance to those with which it had been conversant while on esrth, that it might by degrees be prepared for the more sublime happiness of the heavenly world, This and other conversations of the same kind probably occasioned the following dream..

Its motions serpentine, various and of extreme rapidity-sometimes forcing nearly a complete circle in turning quickly around and sometimes with its head out of water, darting forward at the rate of a mile in three minutes, leaves a wake behind of half a mile in length.

Some of the adventurous seamen of Cape Ann we hear are endeavoring to construct a net of sufficient resistance, to hold the serpent, and prevent his escape.

Mission to Hayti.

The Congress frigate Capt. MORRIS arrived at Port-au-Prince the 22d July, and landed Mr. TYLER, an Agent of the U. States, to make inquiries respecting the execution of an American seaman there, charged with murder. The facts respecting this unhappy affair, we learn are these: -Two of Petion's black soldiers being on board an American vessel, and being suspected of purloining, the sailor was ordered to turn them out of the vessel. In doing this, he struck one of them on the head with a stave, as he was passing over the side of the vessel, which occasioned his fall into a boat along side, and his immediate death. The transaction created a great fermentation among the soldiers at Port-au-Prince; and the sailors apprehended, and shot the same day. Several Masters of American vessels waited on Petion, to expostulate with him on these summary measures, and to request that the sailor, as a citizen of the U. States, might he tried before a Civil Court. President Petion, it has been stated to us. la: mented the occurrence, but refused to comply with the request; as the laws of the Rezublic, har alleged, authorised the resort to court martials in all cases when the public tranquility would be hazarded by the delays of a civil process. If these have been found to be the facts, Mr. Ty. ler probably has acquiesced in this administration of the laws of an independent State.

The Congress left Port-au-Prince the 27th July for Cape Henry, to make certain demands of King Christophe. If we recollect right, the subject in controversy between us and this black Prince, relates to events of long standing. We have been told, that some American merchants, in a speculation of gun powder, déposited a large quantity of it in Cape Francois; which, was seized, used or confiscated, by DESSALINES, the predecessor of Christo-PHE: - That in consequence of this seizure, when Christophe transmitted coffee, &c. to Baltimore, to raise a fund of 140,000 dollars, to build a frigate for his service, it was there seized, as an effect for the sequestrated gunpowder:-and that, when the black King was made acquainted with this last transaction, he contended, that he was not answerable for the conduct of Dessalines, and ordered the confiscation of American property to the exact amount of the seizure in Baltimore (140,000 dollars) and then directed, that the intercourse between the two nations should continue as heretofore. This, as far as our recellection serves, is the subject in controversy. The owners of the American property have made frequent representations to government on the subject; and it is probable Mr. Tyler is authorised to bring the controversy to a close.

The Congress reciprocated salutes with the forts; and President Petion expressed. to Capt. Morris his pleasure in seeing, for the first time, an American frigate in his

"Yes," said he, "my time is spent, may God have mercy on my soul," and was immediately launcned into eternity.
