The smaller vessels are principally stationed at 'important passes, for the purpose, as I understand, of protecting our commercial trade from privateers, &c.

Nothing is omitted in this list, which can he conducive to make it correct, the compiler having taken much pains on that point—therefore, those who wish a com-plete and correct list of the naval force of our country, will not hesitate in giving this a preference. Subjoined is a list of the infant but flourishing navy of Buenos Ayres. It comprises all the vessels of war regularly commissioned by that republic, and destined to cruize in the Atlantic ocean.—There possibly may be other cruizers which have obtained, and still hold commissions from the Buenos Ayrean government, but having subsequently procured others from Artigas, to qualify them for capturing Portuguese vessels, tbey have forfeited the former; nor dare they show themselves in any port within the jurisdiction of Buenos Ayres and are liable to be captured when fallen in with ty the regular armed vessels of that goernment. These are the pirates of whose infamous proceedings we have had so many accounts, it is with vessels of this stamp that the lawfully constituted cruizers of Buenos Ayres have been unjustly associated in the public mind, aild it is for their crimes that the flag of the new republic has been so long antl so cruelly stigmatized.

Besides the vessels here enumerated, there are many others cruizing in the Pacific and Indian Oceans, some of which are of a large class.

Bic graphy of Carnot.

[Transland] m the French for the New Englan

This sketch is interesting, though it does not render sufficient justice to Carnot, one of the greatest and purest men in Europe.-In science and in war combin-

Lazare Nicholas Marguerite Carnot was born at Nolay in Burgundy, May 31st, 1753. At an early age he was placed in the corps of engineers, when his assiduity in study and his great acquirements procured for him a rapid promotion. An eulogy on marshal Nauhan, and some well written verses, caused him to be noticed by several learned societies. He was captain of engineers, and knight of St. Louis, when the revolution took place. He took the popular side, and in September, 1791, was a deputy to the legislature, from the department of Pas de Calais. One of his first proposals was directed against the emigrant princes, whom he wished to have formally accused for having abandoned in a kind of obscurity, attentive only to their country and taken arms against it. his family; and in 1811 was appointed He afterwards proposed to replace the officers by sergeants, and erased from the rules of war, the principle of passive obedience to officers. He caused 300,000 pikes to be manufactured, for the purpose of arming the Sans culottes, and was afterwards deputed to the camps of Soissons and Chalons where he notified the army of Luckner, of the decree, which dethroned Louis XVI.

Carnot became a member of the national convention, and voted for the death of the king. In March 1793, he set out for the army of the north, and cashiered on the field of battle general Gratien, who had retreated from the enemy. He afterwards marched himself at the head of the republican columns, and animated them by his presence. On his return to the convention, he was appointed a member of public safety, which governed under the name of the convention, and was itself governed by Robespierre. From that time he began to exercise a powerful influence over all the military operations. All the plans deposited in the office of the minister of war, from the days of Louis movements of the French armies, and ap-peared anxious to appropriate to himself this kind of glory; and it is said that he battle of Maubeuge, at which he was preed, that the memorials and instructions a great measure to the victories of the French; and to Carnot the country is certainly indebted for a large portion of her military glory.
